



Small Business Checking

Custom built for organizations that have few monthly transactions like sole proprietorships or HOAs. Only \$100 to open, includes unlimited ACH activity, and earns interest on balances over \$1,000. \$10 monthly fee required for balances under \$300.

Regular Business Checking

Designed for businesses that expect to have more monthly transactions, such as small offices and self-employed service providers, this account requires \$500 to open, includes ACH activity, and earns interest on balances over \$1,000. \$15 monthly fee required for balances under \$2,500.

Business Growth Checking

For businesses with a high volume of banking transactions such as hair salons or retail stores, this account requires \$1,000 at opening, offers unlimited deposits and transactions of all types and earns interest on balances over \$1,000. \$20 monthly fee required for balances under \$5,000.

Small Organization Checking

Non-profits and other small organizations can take advantage of this account with no monthly fee and no minimum balance.
